SALES CONDITIONS

1) Your visit

Please use one reservation form per visiting date or group.

Payment for the entrance tickets is to be carried out (in cash or by card) at the cash desk of Mini-Europe on the day of the visit according to the real number of participants.

Price supplements for guided visits or didactic programs have to be made directly to the guide.

All bookings for the restaurant or guided visits have to be booked by written reservation. The booking only becomes definitive after written confirmation by Mini-Europe.

- When booking we ask you to inform us about the right number of participants. Whenever the number of participants changes with more than 5 participants, Mini-Europe has to be informed at least 7 working days before the visit.
- Take into account between one and a half and two hours for a visit of the park.
- Each visitor has to respect the park regulations during his visit.
- The behavior of the children remains under the responsibility of the accompanying adults, please do not leave them without surveillance in the park.
- All our rates and descriptions are subject to any modification. Rates and conditions for the birthday package are only valid as of 10 paying participants and for children up to 14 years old.

2) Guided visits

Guided visits must be booked in advance (at least 2 weeks in advance) and are subject to the availability of guides.

Guided visits take place in groups of maximum 25 persons per guide. The supplement for the guided visit is €97 for a group of 25 persons. If the group arrives late, the guide will wait max 1 hour. After this period the total amount will be demanded.

3) Lunch at Mini-Europe

The birthday package has to be booked at least 2 weeks in advance.

The prepayment of the total amount covering the cost of the birthday cake has to be paid within 3 days following the reception of the confirmation of Mini-Europe. In case of absent participants on the day of the visit, there will be no reimbursement of those parts of the cake

In case of cancellation or if the number of participants decreases with more than 5 persons, and Mini-Europe was not informed by email at least 7 working days before the day of the visit, the total amount of ordered parts of cake will be charged.

For the smooth running of services, we ask you to respect the agreed upon hours. In case of delays of more than 30 minutes, Mini-Europe should be informed immediately. Mini-Europe cannot be held responsible for a bad service if the group arrives more than 1 hour late without informing.

Your ordered menus or cancellation will only be valid upon presentation of the written confirmation by Mini-Europe.
